# What is Advocacy Planning?

Advocacy planning theory believes that planners should act as advocates for the values they believe in or for specific interest groups<sup>1;2</sup>. This goes beyond planning in a purely technical or scientific way<sup>1</sup>. Advocacy planning theory also proposes that planners operate within the ~~democratic~~ democratic, political system, which ideally results in pluralistic and inclusive planning<sup>1</sup>. Another important component in advocacy planning is empowering the public to have a larger role in the planning process by ensuring the public has access to all of the information they need in a form that is understandable.





# ***My Role As Planner***
